This week, the National Crime Agency (NCA) expressed deep concern over Meta's decision to implement end-to-end encryption on Facebook Messenger, hindering efforts to protect children from sexual abuse. James Babbage, Director General for Threats, deemed this move disappointing, emphasising Meta's crucial responsibility for child safety. He alleges that the encryption impedes law enforcement's ability to identify and report child sexual abuse.

The NCA estimates that if Meta continues to roll out end-to-end encryption as planned, it would result in the loss of the vast majority of reports (92% from Facebook and 85% from Instagram) of detected child abuse that are currently disseminated to UK police each year.

It is therefore more vital than ever that you do not let your child access apps that are not appropriate for their age. Please ensure that you know who your child is talking to and what they are doing online. Technology can be very useful, but it can also present a very significant risk if you do not exercise your parental responsibilities.
